Notes on Individual, Corporate and International Membership:

- a) regarding membership fees, whenever joining does not occur in the beginning of the year, the applicable fee is adjusted according to the formula below:

$$\text{Annual Fee} * \frac{n^{\circ} \text{ of days until the end of the year}}{365} * (M * 6\% + 1)$$

with "M" being the number of complete months of the year already elapsed

- b) Membership fees are to be paid to Quinta da Marinha Oitavos Dunes, S.A.

Notes on Associate and Sócio of ODC:

- c) an Associate must be Sócio of ODC. Associate fee mentioned above includes "Sócio of ODC" fee.
- d) "Associate" and "Sócio of ODC" fees are not adjusted when joining does not occur in the beginning of the year.
- e) "Sócio of ODC" fee is to be paid to Oitavos Dunes Club. All other fees are to be paid to Quinta da Marinha Oitavos Dunes, S.A.

Benefits of the Individual Member

(2.920€/year)

1. Unlimited complementary golf rounds (each round is subject to availability upon booking, which can be made up to 7 days in advance of play date).
2. Possibility of playing on “member only” starting-times:
 - a. Saturdays, Sundays and holidays: from 08:36 until 11:00
 - b. Monday to Friday: 6 starting-times per day, normally:
 - i. 08:00 and 08:12
 - ii. 10:00 and 10:12
 - iii. 12:36 and 12:48
3. Possibility of playing on any starting-time depending on availability.
4. Possibility of associating up to 2 direct family members to his membership contract, for 445€/year/direct family member – Associates
 - a. Eligible family members are: wife, husband, son, daughter, father or mother;
 - b. Associate status is personal and non-transferable, therefore substitution of Associate beneficiary before year end is subject to additional Associate fee.
 - c. Cost and benefits of being “Associate” are listed below;

6. Golf bag storage FREE; additional golf bag at 192€/year
7. Possibility of renting a locker 72€/year
8. Possibility of storing privately owned:
 - a. trolley 120€/year
 - b. electric trolley 240€/year
 - c. buggy 996€/year
9. Possibility of playing Oitavos Dunes Club tournaments
 - a. ± 8 tournaments per year;
 - b. for free (regardless if member is “sócio” of the Oitavos Dunes Club or not).
10. Possibility of using the outside pool of The Oitavos Hotel and bring one guest.
11. 10% discount at the Oitavos Dunes pro-shop and The Oitavos Hotel shop.

12. 10% discount at the Verbasco Clubhouse Restaurant and The Oitavos Hotel restaurants.
13. 10% discount at the *The Spa* (The Oitavos Hotel balneotherapy and massage & treatment center).
14. 10% discount in room rates at The Oitavos Hotel
 - a. The 10% discount rate will be applied over the best available rate at the moment of booking/purchase (including “packages”, excluding “special offers”);

 - c. Booking/purchase has to be made by email to reservations@theoitavos.com mentioning the full name of the Oitavos Dunes Member.→ Early bookings generally benefit of lower room rates (over which the 10% discount will be applied).

Benefits of the Corporate Member

(3.995€/year)

The Corporate Membership entitles the individual representative of the contract holder (the corporation) to the exact same benefits that a regular individual member is entitled to (see above “Benefits of the Individual Member”), plus 36 complimentary golf rounds for corporation invitees.

Benefits of the International Member

(695€/year)

The International Membership targets Oitavos Dunes enthusiasts:

- who live far away from Oitavos Dunes and therefore need to overnight nearby in order to play the course,
- and that would be keen to stay at The Oitavos Hotel (at special rates).

The International Membership entitles the contract holder to the exact same benefits that a regular individual member is entitled to (see above “Benefits of the Individual Member”).

The International Membership is roughly 75% cheaper than the normal membership. Such discount is justified by:

- the fewer opportunities that a non-local golfer has to play the course;
- the mandatory requirement that the International Member has to overnight at The Oitavos Hotel (Oitavos Dunes sister company) in order to play the course.

Benefits of the Associate

(365+80=445€/year)*

1. Greenfee rates:

- a. If playing with the "Associate" (same flight): FREE
- b. If not playing with the "Associate":

→ in these situations Associate cannot tee-off at member's exclusive starting-times.

1. Affiliation with the Portuguese Golf Federation (FPG), that entitles to:

- a. Official handicap registration and management
- b. Discounted greenfee rates in most portuguese golf courses
- c. Other FPG benefits

→ Affiliation with the Portuguese Golf Federation (FPG) will only be made after being requested by the Associate;

2. Possibility of playing ODC tournaments

- a. ± 8 tournaments per year
- b. at a rate of 50€/tournament

Note:

To be eligible to become an Associate, a golfer must be:

- A direct family member (wife, husband, son, daughter, father or mother) of a Oitavos Dunes Member properly appointed by the latter – the "Parent Member" – to be one of his two Associates;
- Sócio of ODC.

* the Sócio of ODC fee is included in the Associate global fee mentioned above.

(80€/year)

Introduction

Oitavos Dunes Club (ODC) is the entity that represents members of Oitavos Dunes towards:

- **Quinta da Marinha Oitavos Dunes S.A.** – the entity that owns and manages Oitavos Dunes (entity from which memberships and green fees in general are bought);
 - ODC influences and contributes to the members' events calendar;
 - ODC identifies and defends members' viewpoints (on course, facilities, etc).
- **Portuguese Golf Federation;**
 - ODC ensures each sócio gets its amateur license (affiliation with the Portuguese Golf Federation);
 - ODC ensures each sócio official handicap registration and management.

Nearly 75% of each sócio ODC fee is used by ODC to pay for the correspondent affiliation with the Portuguese Golf Federation (amateur license).

To be eligible to become Sócio of ODC, a golfer must be:

- a Oitavos Dunes Member, or
- a direct family member of a Oitavos Dunes Member (Associate or not).
